From the Chair

Since our last newsletter, MOSAF has been busy with our winter meeting, dealing with policy issues, selecting scholarship recipients, working on communications policies, getting ready for the next Missouri Natural Resource Conference (MNRC), setting up our spring meeting, and moving our outreach and education efforts forward. We have developed a revised strategic plan which guides our direction for the next five years.

Our winter meeting was well attended and we heard updates from committee chairs and several partners. The greatest concern discussed at this meeting was the introduced legislation at the Missouri General Assembly and how it will affect forestry if passed.

We received a verbal report from Greg Hoss our District IX Council Representative and heard updates from partners.

Mike Hoffmann, Nominating Committee Chair, announced our MOSAF scholarship recipients at our winter meeting. Congratulations to *Lance Dolman, MOSAF scholarship, Brendan Woodall, Ed Stegner Scholarship via Missouri Conservation Federation and Jeffrey Schniederman, Graduate scholarship.*

Several committees have been busy. The Communications Committee recently proposed two policies to deal with partner announcements and sponsorships in our newsletter. The Executive Committee reviewed and approved both of these policies. Both of these policies can be found on MOSAF's website. The MNRC committee is "neck deep" in planning for next year's MNRC. They have been working on reserving speakers for the conference. The Policy Committee has been busy. They were asked to review several introduced bills and provide comments via a letter to the Senate President and/or the Speaker of the House. They reviewed HJR 27, HB 833, SB 337, and HB 763. HJ 27 would reduce the Missouri Department of Conservation's dedicated sales tax from 1/8 to 1/16 of one percent. The reduction in sales tax revenue would affect forestry in Missouri by reducing the funds the Missouri Department of Conservation (MDC) would have to spend on programs like the Professional Timber Harvesters program, the Master Logger Certification program, the Landowner Assistance cost share program, and the amount of private land assistance to forested landowners. HB 833, if passed, would eliminate clear cutting on MDC land and would assign a consortium to review and approve MDC Forestry Division's management activities. This bill has the potential to eliminate a valuable tool such as regeneration harvesting (clear cutting) from the MDC tool box. There are certain forest conditions (i.e., health issues) and wildlife habitat requirements that require this harvest method. SB 337 and HB 763 seek to "prohibit the MDC from engaging in prohibited conduct with connected not-for-profits." These two bills, if passed, could eliminate MDC's partnerships with organizations such as volunteer fire departments, NWTF, QU, Forest Woodland Association of Missouri, and many other not-for-profit partners. MOSAF had the pleasure to award the Karkhagne award to Steve Shifley at the Missouri Natural Resource Conference. Steve's accomplishments throughout his career as it relates to forestry are outstanding. Congratulations Steve!

Congratulations to our newest Golden Members. Todd Kinerk joined SAF in 1962 and Art Suchland joined in 1965. MOSAF is proud of your dedication to our profession and enjoyed recognizing your efforts at the winter meeting and at the Missouri Consulting Foresters Association's winter meeting. Thank you Todd and Art for you contributions to MOSAF throughout the years.

In closing, MOSAF has been busy with the topics above. I have had the pleasure this past year to work and communicate with outstanding people in MOSAF and SAF. Thank you for your dedication to our society.

Tod Kinerk and Art Suchland, 50-year members of SAF!

MOSAF Members Tod Kinerk and Art Suchland recognized as 50 Year Members by SAF - *Mike Hoffmann, MOSAF Awards Committee Chair*

Tod Kinerk and Art Suchland were presented framed 50 Year SAF membership certificates at the Missouri Consulting Foresters Association Annual meeting on Feb 19 (*editor's note – Tod and Art*

were also recognized at the MOSAF business meeting at MNRC 2015). Both received Forestry Degrees, served in the Army including assignments in Vietnam and worked briefly outside of Missouri but both served most of their forestry careers in Missouri.

Tod Kinerk graduated from Purdue University with a degree in Forest Management in 1962. He accepted a position with the BLM in Oregon for a year and a half was then drafted into the Army where he served nearly 2 years including a tour in Vietnam. Following his discharge from the Army, Tod accepted a job with the Forest Service in Doniphan, Mo, then briefly worked on the Chequanegon NF on a Job Corps assignment. He then transferred to a position on the Shawnee NF where he worked a year in the Supervisors Office and four years on the Jonesville Ranger District. Tod transferred back to the Mark Twain stationed in Salem in 1975 where he worked in Real Estate. He retired from the Forest Service in 1994 and has been working as a Consulting Forester ever since (*editor's note – Tod has also been instrumental in planning the Timber Fun Days held in Salem each Labor Day Weekend*)

Art Suchland graduated from the University of Missouri with a degree in Forest Management in 1965. He immediately accepted a job as an Assistant Farm Forester in West Plains. In April, 1966 Art was drafted into the Army. He completed basic training at Ft. Wood, then Construction/Survey training at Ft. Belvoir, VA. He then did a tour of duty in Vietnam working in a Construction/Survey Unit. Following his discharge from the Army, Art took a position with the City of Denver, CO Parks & Recreation Dept working in Urban Forestry. In the fall of 1968, Art retuned to Missouri as the RC&D Forester in Houston. In the fall of 1969, Art transferred to Hannibal as the Farm Forester. He was promoted to Forestry Regional Supervisor for the Northeast Region where he served until his retirement in 2002. Art then worked as a Consulting Forester through 2013 (*editor's note – Art is active in the Tree Farm Program and is a Certified Tree Farmer*).

We congratulate Tod and Art for 50 Years of service to SAF and to the forestry profession. We are proud of the contributions they have made to forestry in Missouri and their service to MOSAF, the Mark Twain National Forest, The Department of Conservation and the Missouri Consulting Foresters Association.

Benefits from Trees

The article below is for you to use with your local media to get out the word that good forestry provides benefits and MOSAF can help with it. Add a photo if you wish.

Plant an Air Conditioner

Summer is coming and high air conditioning bills with it. You can do something now to help lower your future air conditioning bills – the Missouri Society of American Foresters encourages you to PLANT TREES!

Trees provide cooling by direct shading of buildings, driveways, streets, air conditioners, and lawns. Wherever the shade is cast will be several degrees cooler than surrounding unshaded areas. We all enjoy sitting in the shade on a lazy summer day as evidence of this. You can use this shade effect to cool your home.

During the summer, heating of buildings by the sun occurs mostly in the morning and late afternoon. This is due to the orientation of the sun in relation to windows in a building. The low sun during these periods of the day provides direct sunlight entry through windows, while during the middle of the day the sun is high and sunlight does not directly enter windows. Blocking the sunlight from entering windows will reduce the amount of heat entering your building and reduce the need for air conditioning by ten percent.

To get the most benefit, plant trees on the east – southeast and west – southwest sides of your home to block windows from the sun. Planting on the south has less effect due to the suns' track across the sky goes over our homes and has little opportunity for directing sunlight into south facing windows.

Take advantage of our natural air conditioners and PLANT TREES!

First, we need ideas for a catchy phrase for the poster. For example: Forestry – A Career That Grows. Ask teens you know to filter your ideas. They are the target audience.


Details like looking for a forestry school can be done with tri-fold brochures which allow easier updating.

Missouri Consulting Foresters Association

I am following Shelby Jones as executive director of the Missouri Consulting Foresters Association (MCFA). Thanks to Shelby for having organized an efficient administrative operation for the executive director.

Here are some things that impress me: MCFA is 47 members strong with 30 members (64%) belonging to SAF; 24 members are Certified Foresters through SAF; 11 members are certified through ISA; 8 members are retired, most of whom are SAF members; and 18 members are cooperating with the Call Before You Cut Program (CBYC). I think the diversity that MCFA offers to MOSAF is to be continued through various training opportunities and interaction with agencies and forestry related organizations.

(MCFA) held its annual meeting in February in Jefferson City. The meeting was attended by 43 people. A total of 27 MCFA members attended; the additional 16 folks were speakers and guests. Technical training was offered to members and guests covering a wide range of topics: Discussion of a variety of issues confronting consulting foresters; tree scaling, weight scaling logs; legal and "red flag" business expenses; tax issues; causality loss from storms and trespass; wildlife habitat considerations for forestry plans; cultural and historical considerations for foresters; learning of a unique service using goats for brush control on food plots and site preparation; learning about repellent products for deer and other problem animals (other than raccoons); news about Rapid White Oak Mortality and other forest health threats; and news from NRCS and MDC. A total of 10.7 hours of SAF - Category 1 CFE credits were available to attendees.

Business meeting topics included electing a slate of officers: Matt Arndt as president, Doug Enyart as vice chair, Chris Lohmann as secretary, and Bruce Vawter as treasure. Members of standing and Ad hoc committees were approved. SB 337, HB 763: placing restrictions on MDC dealing with Non-Profit organizations and SB 833: limiting clearcutting on MDC lands and naming MCFA and other organizations to write management plans on MDC land were discussed. Letters of opposition to all three bills were written and have been sent to various elected officials. It's important to clarify that SB 337 and HB 763 address 501c3 not for profit charitable organizations. While MCFA is a not for profit; it is not a 501c3.

CBYC Program accomplishments to date are: Referral of 47 owners to consultants and the owners of 29 farms have been in contact with a professional forester about their forest resources and receive a Site Visit Report outlining tree species, forest health issues and site conditions plus a map of property boundaries on an aerial photo background. The recent promotion of the CBYC Program in the Missouri Conservationist Ombudsman section resulted in 17 referrals that have been sent to consultants for action. To date over \$10,150 has been paid to consulting foresters for servicing these referrals.

Loss of the CARES clip and download feature on the Map Room at the University of Missouri is a blow to consulting foresters who need GIS data to make maps for management and harvest plans. It is a budget decision to drop the clip and download feature that allows extracting GIS data from the larger county size aerials, topo maps, roads and streams layers. Rather than taking a few minutes to download the clipped GIS data it would take hours over a fast internet connection and fast PC processor to down load county wide GIS data causing map making to grind to a halt. Matt Arndt, Nate Goodrich, and Mike Morris have been working for a solution through use of other web services allowing extraction of GIS data.

Plans for MCFA include completing a financial and marketing survey of members, updating and reprinting the MCFA directory of members and services they offer, developing the program for the Fall Meeting, and investigating fund raising workshops targeting forest owners. MCFA may be small in number of members but it's a busy organization.

Meeting Minutes

MOSAF Executive Committee, February 4, 2015, Tan-Tar-A Resort, Osage Beach MO

Attendees: John Tuttle, Greg Hoss, Nate Goodrich, Jon Skinner, Lynn Barnickol, Paul Johnson, Mike Fiaoni, Susan Troxel DeWitt. George Kipp, Joe Alley

Lynn Barnickol provides a draft of a member survey and asks the committee to take the survey and return it to him at the end of the meeting.

The questions are probably going to end up being too lengthy for the free version of Survey Monkey, he's trying to determine how much time to purchase the pay version for. He solicits input on the questions.

Greg Hoss update: He anticipates taking ten minutes in tomorrow's meeting of the membership.

He reports that the sale of Wild Acres is complete and the money has been received. (\$15M). They are taking 120 days to invest the money with the firm they selected so that they can enter the various investments at market low points. Willmington Trust M&T Bank is the investment firm. The goal is to have the \$15M make a 3.5% interest rate. There are tight guidelines in place for how the money can be spent. There has to be a payback plan for withdrawals.

The Grosvenor Mansion that is the SAF headquarters will undergo an architectural study by the company who bought Wild Acres. SAF sold 35 acres. The company will be building high end townhomes on 18-19 acres of that land. The 8 acres around the Mansion will remain as green space. 11 acres will be a city park. It may take millions to rehab the Grosvenor Mansion. It was built in 1923, SAF acquired it in the 1960s and fixed it up some then, but nothing since then so it looks really dated and shabby. The Grosvenors were the ones who established National Geographic but so far there's been no interest from that organization to assist with renovation. They are planning a capital campaign to raise money for the renovation.

Foresters Fund will be increased from \$30,000 to \$60,000 annually. In addition to the weekly eforester they will start a monthly leadership electronic newsletter. There will be no dues increases for the foreseeable future. No decreases however. Finances are on a stable footing similar to what we had prior to a membership drop off that started 10 years ago.

Patricia Adadevoh's position was changed from Administrative Secretary to the CEO to Leadership Program Director. She works for the Board of Directors (previously called the Council) and as liaison to state leadership. She will be looking for ways to expand services to state chapters.

Greg is in his last year on the Board for District 9 and so a new candidate will be needed in the next election cycle.

Matt Manashes, the CEO was previously with a paddlers non-profit so he knows the Ozarks. We need more services to get more members, and Matt has a good background in Association work to tackle that.

The Founder's Circle program which solicits \$1900 donations from folks (to commemorate our founding in the year 1900) has about 400 members.

Greg requests that the Executive Committee invite Matt Menashes to come to MNRC next year when MOSAF is hosting. Mike Fiaoni indicates this has already been accomplished, he's been invited as a plenary speaker. It was also suggested to have a social with student with Matt at the next MNRC on Wednesday.

Clark Seeley is the incoming president of SAF, currently he is VP.

John Tuttle: Joe Alley has sent a draft strategic plan that the Executive Committee needs to review. May need to be fleshed out some with implementation goals.

PLT has requested to use MOSAF logo. Discussion and later approval via email.

Lynn Barnickol: Survey and communications discussion. How should potential members be contacted?

Rabbit trail on the use of drones in remote sensing.

A communications timeline is forthcoming and has since been received from Lynn by email.

Mike Fiaoni jumps ahead on agenda (needs to leave early for student job fair):

Next year's MNRC is MOSAF hosting and will be Feb 3-5, 2016 "Balancing Economic, Conservation and Adaptive Management in a Changing World"

 - Special Funds (George Kipp): Jon Skinner won the Blackjack Award. \$1100 raised for Foresters Fund via raffle and Silent Auction.
 - Tellers (Aaron Moore): No report.
 - Forest Science (Ben Knapp): Not present but passed on that he would like feedback for the committee's work such as a Forestry Papers summary product, white papers and etc. via email?
 - Newsletter Editor (Joe Alley) Needs contributions for the Spring newsletter in March.
 - Website (Jon Skinner): Covered in Communication committee handout.

- MNRC Steering Committee (Mike Fiaoni): Theme for 2016 is Balancing Economics, Conservation and Adaptive Management in a Changing World. Matt Manashes SAF CEO and David Battker, Earth Economics plenary speakers. Paper option for registrations will be looked into.
- Historian (Greg Hoss): No report.
- Membership and Credentialing Task Force Lead: Justine Gartner: Recommendations of the task force were presented to the Board in December but they have not taken action yet.
- Reports from National Office, Greg Hoss, District IX Council Representative:
 - Reports that the sale of Wild Acres is complete and the money has been received. (\$15M). They are taking 120 days to invest the money with the firm they selected so that they can enter the various investments at market low points. Willmington Trust M&T Bank is the investment firm. The goal is to have the \$15M make a 3.5% interest rate. There are tight guidelines in place for how the money can be spent. There has to be a payback plan for withdrawals.
 - The Grosvenor Mansion that is the SAF headquarters will undergo an architectural study by the company who bought Wild Acres. SAF sold 35 acres. The company will be building high end townhomes on 18-19 acres of that land. The 8 acres around the Mansion will remain as green space. 11 acres will be a city park. It may take millions to rehab the Grosvenor Mansion. It was built in 1923, SAF acquired it in the 1960s and fixed it up some then, but nothing since then so it looks really dated and shabby. The Grosvenors were the ones who established National Geographic but so far there's been no interest from that organization to assist with renovation. They are planning a capital campaign to raise money for the renovation.
 - Foresters Fund will be increased from \$30,000 to \$60,000 annually. In addition to the weekly e-forester they will start a monthly leadership electronic newsletter. There will be no dues increases for the foreseeable future. No decreases however. Finances are on a stable footing similar to what we had prior to a membership drop off that started 10 years ago.
 - Patricia Adadevoh's position was changed from Administrative Secretary to the CEO to Leadership Program Director. She works for the Board of Directors (previously called the Council) and as liaison to state leadership. She will be looking for ways to expand services to state chapters.
 - Greg is in his last year on the Board for District 9 and so a new candidate will be needed in the next election cycle.
 - Matt Manashes, the CEO was previously with a paddlers non-profit so he knows the Ozarks. We need more services to get more members, and Matt has a good background in Association work to tackle that.
 - The Founder's Circle program which solicits \$1900 donations from folks (to commemorate our founding in the year 1900) has about 400 members.
 - Clark Seeley is the incoming president of SAF, currently he is VP.
 - A Certified Urban Forester program is being looked at. Working with ISA.
 - SAF has two people working the Hill, key in getting FIA in the budget at \$83M instead of \$70M. Becoming known as the go-to people for forestry issues.
 - Louise Mourgia is now Chief of Staff instead of Assistant to the CEO which will help free up the CEO to get out to the states more.
 - Shelby Jones: Dilemma over Fellows nominees needing national level activity since we don't have sub chapters (require activity at 2 levels).
 - Philmont Scout Ranch has a new Forestry program with a need for Visiting Foresters.
